

Application for Undergraduate Non-Degree Study

An applicant who wishes to enroll at Indiana State University without pursuing a degree—for job enrichment, personal benefits, or as a guest student—may apply for non-degree study. Those wishing to pursue a degree program as a part-time student must complete a regular application for admission and have transcripts from previous schools and colleges sent to the Office of Admissions.

An application for non-degree study is valid for only one fall, one spring, or both summer terms. A non-degree student may generally enroll for no more than six semester hours for the admitted term and has low priority in registration.
