

Undergraduate Application for Readmission

Readmission

If you have had an interruption of more than two calendar years in attendance at Indiana State University, you must file this application for readmission with the Office of Admissions. This application requires official transcripts of all credit course work taken since your last Indiana State enrollment. If you formerly were a degree-seeking student and are on academic dismissal, you cannot enroll as a non-degree student. A student who wishes to continue studies at Indiana State after completing an associate degree should submit an application for readmission.

After Academic Dismissal

If you were dismissed because of poor scholarship, you may apply for readmission if you are eligible under the provisions of the retention standards in the *Undergraduate Catalog*.

If you were dismissed at the end of the fall semester, you may not apply for readmission in the next semester. If you were dismissed at the end of the spring semester, you may, under certain conditions, apply for readmission in the summer session which follows.

Your academic dean determines whether you may return. If you were dismissed for academic reasons and have not taken classes for more than one calendar year, you may apply for readmission through the Office of Admissions. If you are readmitted, you will enroll on academic probation and have one semester to meet the required cumulative grade point average.

If you were dismissed for improper conduct, you may not apply to the academic dean for readmission until your return has been approved by the Office of the Dean of Students.

No student may be readmitted if dismissed three times.
