The conditional assessment will begin in fall 2020.

Conditional Admission Policy: While the university cumulative GPA at application to the teacher preparation program (BCP1) is 3.0, candidates whose university cumulative GPA is between 2.5-3.0 will be considered for a conditional admission. Candidates whose GPA is between 2.5-3.0 must provide a Letter of Recommendation from a faculty member or employer. Letters of recommendation should discuss the candidate's academic ability, employment success, and/or other attributes that would demonstrate the candidate would be successful in an educator preparation program. Conditional admission candidates will need to have a university cumulative GPA of 3.0 for admission to BCP II (before student teaching).
