Call To Order:

The Indiana State University Board of Trustees met in regular session at 2:00 p.m. on Thursday, September 9, 2010 in the State Room, Tirey Hall.

Trustees present: Mr. Baesler, Ms. Bell, Mr. Carpenter, Mr. Huckleby, Mr. Lowery, Mr. Minas and Mr. Pillow. Trustees absent: Mr. Alley and Mr. Pease.

President Bradley, Vice Presidents Beacon, Maynard, McKee, and Tillery and Ms. Sacopulos, University General Counsel and Secretary of the University were present. Also attending were Dr. Steve Lamb, Chairperson, University Faculty Senate, Ms. Roxanne Torrence, Chairperson of the Staff Council and Mr. Steven Flowers, President of the Student Government Association.

There being a quorum present, Mr. Carpenter called the meeting to order at 2:05 p.m.

Reports:

Report of the President of the Board (Mr. Carpenter)

Comments of Trustees President Ron Carpenter:

We are cautiously optimistic about enrollment numbers for this fall and are very pleased with the results we have been achieved this school year in the number of new students. Thanks to John Beacon, his staff, and everyone involved for their efforts.

We are also pleased to see Terre Haute being recognized as the 2010 Community of the Year by the Indiana Chamber of Commerce. This designation is an honor for Terre Haute. I lived in Terre Haute for a while and have always enjoyed my association with the community.

The Trustees held their Board Retreat on August 27 in Indianapolis. All Trustees were in attendance at the retreat. Following is a report of concerns the Trustees discussed:

We reviewed institutional progress as it relates to the Pathways to Success, the Strategic Plan, and other initiatives. Though we are making adequate progress on most objectives, we are concerned as a Board on a few issues.

Issue 1 – ISU’s Strategic Plan articulates excellence in Community Engagement and Experiential Learning as central to the future of the University. At the center of this initiative, as with most University initiatives, is the work of our faculty. For our faculty to fully embrace Community Engagement and Experiential Learning, we must broaden our definition of the work of our faculty to enable them to connect with the critical economic, social, and environmental challenges facing our communities.

The Board is fully aware of the challenges related to redefining the work of faculty and has discussed this on multiple occasions. The Board is also aware of the progress of the University in reviewing and revising standards for the promotion and tenure of its faculty to enable faculty to support the goals of engagement and experiential learning. However, we have been made aware that not all academic units have completed the revision of their promotion and tenure guidelines. It is critical that this work be completed and that it be completed during this academic year.

Issue 2 – ISU’s Strategic Plan articulates excellence in Community Engagement and Experiential Learning as central to the future of the University. Goal 2 of the Strategic Plan states that ISU will “Advance experiential learning to where all ISU students have a significant experiential learning experience within their major.”

Many academic majors meet this goal. In fact, many majors have included a significant experiential learning experience for many years. It is now time to ensure that all students have such a learning opportunity.

Issue 3 – Many segments of society are demanding greater accountability of higher education. These demands are coming from the public in general, from legislative bodies, from elected officials, from the Indiana Commission for Higher Education and from accreditation groups like NCA, which will visit us later this term. The Board wants to ensure that ISU is in a position to demonstrate to the public that we are worthy of their support and that we do an excellent job in educating the citizens of Indiana. A major part of our accountability requirement is the expectation that we are systematically assessing academic programs to ensure that students are well-prepared. It is the Board’s expectation that all departments and colleges will systematically assess their academic programs to ensure that all students have the required skills and knowledge.

Issue 4 – Goal 1 of our Strategic Plan focuses on ISU’s commitment to ensuring student success. We are also aware that the Indiana Commission for Higher Education and the Governor are also defining expectations of student success for each of Indiana’s public universities. Student success means improving retention rates and improving graduation rates.

The Campus has initiated multiple strategies focused on student success. Of major importance to the Board is improving graduation rates especially for the 4-6 year period. Each year Board members hear stories that students cannot graduate in 4 years because the University does not schedule its courses in the proper manner, that our programs have no electives, that students change majors and add an extra year or more to their program, etc. In general we hear that some students have significant problems graduating in a timely manner.

Our Charge: All four of these issues are important to our students and to the future of the University. The first three are issues that the University has been working on for an extended period of time. The Board expects that these three issues be appropriately addressed by the end of this academic year. The Board would like an interim report at our May 2011 meeting and a final report by next summer on each of the three issues.

We recognize that the fourth issue is very complex. We are asking that the Provost work with the campus and develop a plan of action to address this important issue. This report should also be completed by no later than the end of this academic year.

The Board is charging the Provost to work with the campus faculty to study our perceived and real barriers to graduation and to present a creative plan of action that will make it possible for students, both traditional and nontraditional, to graduate in a more timely manner. This plan shall be reported to the Board by no later than our May 2011 Board meeting.

I also attended the Indiana Trustees Academy on August 30 in Indianapolis. The program included several speakers, with Governor Daniels as the keynote speaker. The program focused on the fiscal responsibilities of college and university Trustees. Mr. Carpenter noted that Indiana State University has already taken several steps in order to keep costs under control.

The Trustees recognize that Dr. Bradley is completing his third year as President and we will soon be conducting an evaluation of his performance. We will be searching for an outside firm to conduct the evaluation. Trustee George Pillow will head a Committee to include Steve Lamb, Roxanne Torrence and Melony Sacopulos. That committee will report back in a month to report about the selection of an outside firm to perform the review. We hope to get input from faculty, staff, students, administrators, and community members for the review. The result of the process will not be public information. This review is strictly for the use of Trustees.

Finally, congratulations to the football team on their recent win and good luck to them and all the athletic teams for a successful season.

Report of the Faculty Senate Chairperson (Dr. Lamb)

Dr. Lamb, Chairperson of the Faculty Senate, submitted the following report.

The Faculty Senate has met since the last Trustee meeting. A healthy environment exists in our domain as a direct result of the vitality of the institution as reflected in the enrollment reports. It is hard for even the Faculty Senate to be grumpy. Thanks again, goes to Vice President Beacon and all who worked on enrollment efforts.

The Faculty Senate has established the membership of all the faculty standing committees and has sent each of these standing committees charges for their deliberation.

The Faculty Senate has approved the creation of two new minors in Technology, the Unmanned Aerial Vehicles Minor and the Lean Six Sigma Minor. We also approved the creation of a Sales and Negotiations Minor housed within the Scott College of Business. The Family and Consumer Sciences relocation proposal, a very complex proposal involving three colleges, also passed through the Senate body.

We deleted the B.A. in Music History and Literature, the B.A. in Music with a Concentration in Music Theory as well as the B. S. in Music/Choral. Basically, three majors were eliminated, and three minors created subject to your approval of such actions.

The Faculty Senate is working aggressively with the administration to establish a bi-annual Faculty Evaluation process. It is my expectation that the process will be taken to the Faculty Senate in October or December.

We are also reacting to, or supplying input into the administrations algorithm for the distribution of monies to faculty that will occur this year. I do want to say that generally faculty does not react positively when monies are only used to mechanically address those salaries that are far below market, without substantive input as to the productivity of said individuals. We need to make substantive efforts to reward those who are recognized as being some of our best performers, and they are not usually those individuals who are the furthest below their market value, with some notable exceptions; however.

I am pleased that the administration is stating that a minimum of 75% of the monies will be distributed throughout the faculty based upon a successful binary performance review evaluation. I am also very pleased with the President's understanding that keeping salaries competitive is vital for a healthy institution. I personally think that the magnitude of the raises that he has established when one moves from assistant to associate, and from associate to full, will do much in the long run to thwart compression, and keep salaries competitive.

The institution has made enormous strides under the President's leadership. I do ask the President to remember that in any long run endeavor, one has to be mindful of the pace that is set. Let us not burn our capable administrators. Let them have breathing room, give them the encouragement necessary that they feel empowered to aid in the decision making. Give them the flexibility and the trust to move their own units forward. Provide a strong vision, and give them the tools that they may move their units forward. Allow them to celebrate their successes. We want them to be here for the long run.

These are most positive times.

Report of the Staff Council Chairperson (Ms. Torrence)

Ms. Torrence, Chairperson of the Staff Council, presented the following report.

It is great to have the students back on campus.

The increase in enrollment is a great way to start the semester. While this achievement was the hard work of so many, I would like to thank Vice President Beacon for his leadership in the recruiting efforts. It is a great accomplishment for the entire campus and no doubt moving the University in the right direction.

The 2010 Sycamore Staff Award was presented at the Council Annual Meeting which was held in July. This award recognizes a staff member who contributes to and supports the Council by their attitude, service, and engagement. I am proud to announce that this year's winner was Alvin Stinnett from Facilities Management and a recent retiree.

The Scholarship Committee completed the applicant screening process and I am happy to announce that we awarded 6 staff scholarships this year in the amount of \$600 each. The recipients were recently recognized at our annual retreat. The winners of the Staff Scholarship are: Stephen Duzan, Christie Jacob, Patricia Kennedy, Sue Murphy, Amanda Owen, and Donna Ring. Congratulations to you all.

I would like to recognize Teresa Sale from the Controller's Office. I recently received an email from Teresa who had reached out to her colleagues in her building asking for a donation of school supplies that would be donated to the Salvation Army. Within four days, she was able to collect almost 100 items and \$80 in cash. Thank you, Teresa for helping make a difference in our community.

I hope everyone has a great semester.

Report of the Student Government Association President (Mr. Flowers)

Mr. Flowers, President of the Student Government Association, submitted the following report.

The beginning of the school year has been exciting with so many students filling campus and the air full of Sycamore pride. With each new challenge, Student Government is working to find new and better ways to serve students. Without students, we wouldn't have a purpose on this campus and with that in mind we established 3 main goals that we introduced at the previous Board meeting. They include: instilling in students a sense of school spirit and campus unity, partnering with the Terre Haute community in order to give students a more complete college experience, and overhauling the resources provided for students to increase accessibility.

With the beginning of another exciting season of ISU athletics we view this as the perfect opportunity to give students a reason to be engaged, involved and rooting on the Sycamore teams. For years Blue Crew, has been the section at Sycamore sporting events that is more empty than full. We attacked this issue almost immediately after taking office, brainstorming ways to enhance student engagement and see increased turnout. Thanks to publicity and incentives at the first football game, we saw a huge student turnout and gave away almost 600 Blue Crew t-shirts to ISU students. In coming months, there will be “Blue Crew” nights at all of the fall sports featuring theme nights and exciting giveaways from local businesses. In addition, life size Sycamore Sams will be appearing around campus to remind students of upcoming athletic events. These “Sams”, sponsored by various departments, will be just another way of engaging the whole school in Sycamore Pride.

Another way we are working to offer students’ exemplary opportunities while at ISU is through a student-to-student mentoring program. While in the very early planning stages of this project, we envision student leaders being able to work with younger students at ISU in order to build relationships and identifying opportunities for the future.

While Sycamores, students are also a part of this community and, effected by the decisions made here. Because of this principle, SGA will be sponsoring a voter registration drive, with registration tables set up each week in the Commons. On October 25, just a week before the November election, we will also be hosting a candidates’ forum where local candidates will come in and speak to students about the issues facing the community. It is important to us that we have informed active voters, not just numbers.

One of the challenges SGA consistently faces is a lack of awareness among students. In order to combat this we are actively reaching out to students going about their daily lives on campus. We have created key tags sporting the SGA logo, with campus numbers students often need. Our goal is to have the resources they use most often at their fingertips. We’ve received a lot of positive feedback from students who have received key tags and are busy passing out 1000 more. As a group, we are also participating and volunteering at campus events and plan to set up “giveaway-stops” throughout the year around campus to hand out SGA information, prizes and food.

Lastly, working to be student advocates and organizational resources is always our top priority. As a result, the branches of SGA have been working hard to redesign the constitution in order to increase independence within the various branches and make a more effective organization. In the coming weeks you as a Board will have a chance to read through this document and we are excited to share with you the advancements we have made.

We want you to know that SGA appreciates all of the work that you do and look forward to our continued partnership.

Report of the University President (Dr. Bradley)

President Daniel Bradley submitted the following report.

This is a great start to the school year. We have the largest freshmen class in the history of ISU. Residence halls are full with about 70 students staying at the Candlewood Suites Hotel. Move-in, laptop distribution and opening activities all went very smoothly.

For those of you who could not be here for the opening convocation, we would like to share some of the excitement of that evening with you. A video of the program was shown.

As you can see, the energy level has been quite high. We have several members of the admissions and orientation team some of whom have been dubbed the “Blue Crew” with us today. Please join me in congratulating them along with their colleagues across campus who contributed to this success. Our goal now is to sustain this enthusiasm and energy so that we can replicate this success next year. We also need to focus on retention efforts as you heard Associate Vice President Jennifer Boothby describe during the seminar earlier this afternoon.

Another major move forward occurred yesterday when the State Budget Committee released the bonding authority to help fund the renovation of the Federal Building into the new home for the Scott College of Business. Plans call for bids to be awarded in early 2011 with hopes that construction can be completed in time for fall 2012. This will be an exciting development for the Scott College, its students, faculty and staff as well as a great addition to our downtown business community.

I would like to thank Senator Luke Kenley, Senator Tim Skinner, Representative Clyde Kersey and U.S. Senator Evan Bayh for their efforts and also acknowledge the tremendous work of Brian Hasler and Diann McKee in securing this final approval.

On another budget-related issue, the 2011-2013 Biennial Budget process formally begins his week. Tomorrow, I will be presenting our budget request to the Indiana Commission for Higher Education, during the first of several stages of this process.

Last week, Terre Haute was named the 2010 Community of the Year by the Indiana Chamber of Commerce. The award will be officially presented at the Indiana Chamber’s Annual Dinner in November. The city’s nomination included several projects connected to Indiana State and the Indiana State University Foundation. It is clear that Terre Haute is moving in the right direction, and Indiana State is playing a role in areas such as the revitalization of downtown, economic development and the redevelopment of the riverfront. We look forward to continuing our collaboration with various public and private entities to advance our community.

Our football season kicked off in a big way with a 57-7 victory Saturday night at Memorial Stadium. The team’s seven offensive touchdowns set a new school record.

The soccer, cross country and volleyball teams are also starting off with winning seasons and several of our student athletes are receiving accolades for their efforts. The women’s golf team will open their season this weekend under the leadership of new coach Greg Towne.

Please join me in acknowledging their efforts and wishing all of the coaches and teams continued success throughout the season.

Item (IV)(a)(i):

Proposed Name Change for the Indiana State University Rehabilitation Clinic

The Department of Applied Medicine and Rehabilitation proposes to change the name of the Indiana State University Rehabilitation Clinic to Indiana State University Physical Therapy and Sports Rehabilitation Clinic. The department feels that the new, more descriptive title would differentiate the services provided at this location from those offered in other clinics on campus. It would also promote improved understanding of services by community members.

The proposal has been approved by the Dean of the College of Nursing, Health, and Human Services, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: Approval of the name change from Indiana State University Rehabilitation Clinic to Indiana State University Physical Therapy and Sports Rehabilitation Clinic, Fall 2010.

On a motion by Mr. Pillow, seconded by Mr. Minas, the recommendation was approved.

Item (IV)(a)(ii):

Proposed Name Change Center for Public Service and Community Engagement

The Center for Public Service and Community Engagement provides leadership and coordination for the University's expanding community engagement activities. Over the past several years, as the CPSCE staff have interacted with ISU students, faculty, and staff and external stakeholders, it has become evident that "Center for Public Service and Community Engagement" is a title that is difficult for people to communicate and remember. In a 2008 survey of faculty, the majority of respondents knew that there was an office responsible for community engagement but less than a third accurately identified the title.

In order to improve name recognition of the department and simplify communication, changing the name to "Center for Community Engagement" is recommended. The costs associated with a change of name will be minimal, and will coincide with current updates in marketing and office materials.

Recommendation: Approval to change the title of the "Center for Public Service and Community Engagement" to the "Center for Community Engagement," effective October 1, 2010.

On a motion by Ms. Bell, seconded by Mr. Baesler, the recommendation was approved.

Item (IV)(a)(iii):

Proposed Name Change Center for Business Support and Economic Innovation

The Center for Business Support and Economic Innovation (CBSEI) serves as a gateway for the business community and continues to provide ISU students and faculty outstanding opportunities to engage with companies throughout the region.

As the department interacts with a number of business and community stakeholders, and promotes ISU engagement to both internal and external audiences, the title “Center for Business Support and Economic Innovation” is often difficult to communicate and cumbersome for most to say. To better reflect the range of engagement activity performed by the department, changing the department’s title to “Business Engagement Center” is recommended. The costs associated with a change of name will be minimal, and will coincide with current updates in marketing and office materials.

Recommendation: Approval to change the title of the “Center for Business Support and Economic Innovation” to the “Business Engagement Center,” effective October 1, 2010.

On a motion by Mr. Huckleby, seconded by Mr. Minas, the recommendation was approved.

Item (IV)(a)(iv): Academic Fee/Refund Model for Professional MBA Program

The Scott College of Business will offer its Master of Business Administration program off-campus at a location in Hendricks County, Indiana, beginning in the 2011 fall semester and the ICHE has also granted approval. The “Professional MBA” is a two year, cohort-style program, in which all course materials are provided. The 36 hour program will be delivered over six consecutive terms. The following academic fee/refund model is recommended for the program:

Pre-Payment: A \$1,200 non-refundable pre-payment of first term academic fees is required to hold the student’s seat in the in-coming cohort.

Academic Fees: 200% of the ISU in-state graduate academic fees at the time of enrollment. This rate shall prevail for the full length of the program. Students who stop out of the program will be assessed the prevailing rate of the new cohort.

Withdrawals and Refunds: Prior to first day of term, 100% refund, with the exception of the one-time non-refundable \$1200. The First day of term and after, no refunds.

Recommendation: Approval of the academic fee/refund model for the Professional MBA.

On a motion by Mr. Pillow, seconded by Mr. Lowery, the recommendation was approved.

Item (IV)(a)(v): Proposed Policy to allow Paid leave for Community Service

In keeping with the mission and values of the university, the proposed policy set forth below has been prepared to allow paid leave for hands-on community service.

516 COMMUNITY SERVICE LEAVE

(Initially adopted by the ISU Board of Trustees on September 9, 2010, and effective October 1, 2010.)

516.1 Purpose. The University recognizes the importance of community involvement and encourages employees to participate in volunteer activities by providing flexibility in work schedules and paid leave opportunities. This policy governs administration of a community service program.

516.2 Eligible Community Service. Employees may at the discretion of the supervisor, be granted paid leave to provide “hands-on” voluntary service to their communities as part of an organized community service project. For example, delivering meals to the elderly is an eligible activity, but attending a social event for the organization providing the meals would not.

516.2.1 Volunteer Fire and Rescue Members. Members of volunteer fire departments and rescue squads or auxiliary units thereof may be granted leave to:

516.2.1.1 Respond to emergency situations during their working hours; or

516.2.1.2 Arrive after the normal beginning of their work shift if an emergency situation to which they responded outside their normal work hours continues beyond the normal beginning of their work shift.

516.2.2 Excluded Service. Excluded are services provided through a membership organization where the primary recipients of the service are the constituents of the organization (i.e., painting and maintenance of the group’s building, yard work, serving on the board, etc.); and political groups or causes.

516.3 Pre-Approved Activities. The ISU Center for Public Service and Community engagement shall maintain a list of pre-approved activities that are appropriate for use of leave under this policy, and shall be the final arbiter of whether or not a proposed activity is eligible for use of leave under this policy.

516.4 Amount of Leave.

516.4.1 Full-Time Employees. A maximum of 15 hours (16 hours for those working a 40-hour week) of paid leave per fiscal year will be made available to individuals who are full-time, benefits-eligible administrators, staff, and hourly employees as of July 1 of each year.

516.4.2 Part-Time Employees. A maximum of 7.5 hours (8 hours for those working a 40-hour week) of paid leave per fiscal year will be made available to individuals who are part-time, benefits-eligible administrators, staff and hourly employees as of July 1 of each year.

516.4.3 Probationary Employees Not Eligible. Any employee working within their introductory 3-month period is not eligible for this leave.

516.5 No Carryover. Unused Community Service Leave existing at the end of the fiscal year may not be carried over to a subsequent year.

516.6 No Payout at Separation. The value of unused Community Service Leave existing at separation of employment shall not be paid to the separating employee.

Recommendation: Approval of the Policy allowing Paid Leave for Community Service, to be effective October 1, 2010.

On a motion by Mr. Lowery, seconded by Mr. Pillow, the recommendation was approved.

Item (IV)(a)(vi): Biennial Operating Budget Request, 2011-13

Preliminary Operating Budget Request schedules for the 2011-13 biennium were submitted on August 2, 2010, to the Indiana Commission for Higher Education and the State Budget Agency, subject to Board approval. A summary of the 2011-13 Biennial Operating Budget schedule is shown below.

Recommendation: Approval of the biennial operating budget request for the 2011-13 biennium.

**Item (IV)(a)(vii):
Delegation to the President to Set Fees for the Student Recreation Center**

There are many fees related to use of the Student Recreation Center (“SRC”), due to the wide variety of programming offered through the SRC. These fees depend on the number of available days of instruction, and can change from session to session. Greater flexibility is needed to respond in a timely manner to demand for SRC programming.

Recommendation: Delegate to the President of the university the authority to set fees for use of the Student Recreation Center.

On a motion by Mr. Huckleby, seconded by Mr. Pillow, the recommendation was approved.

**Item (IV)(a)(viii):
Proposed Amendment to Campus Tobacco Policy to Provide Penalties for Violation**

The Campus Tobacco Policy provides prohibitions against the use of tobacco on the campus of ISU. However, the Policy currently contains no penalties for violations of the Policy. It is proposed that persons who violate the Policy to be subject to a \$50 fine.

Recommendation: Charge the Vice President for Business Affairs to solicit feedback about implementation of a \$50 fine for infractions of the Campus Tobacco Policy.

On a motion by Ms. Bell, seconded by Mr. Baesler, the recommendation was approved.

University Investments**

In accordance with the Board of Trustees-approved investment policy, the University Treasurer was given authority to manage the short and long-term investments of the University.

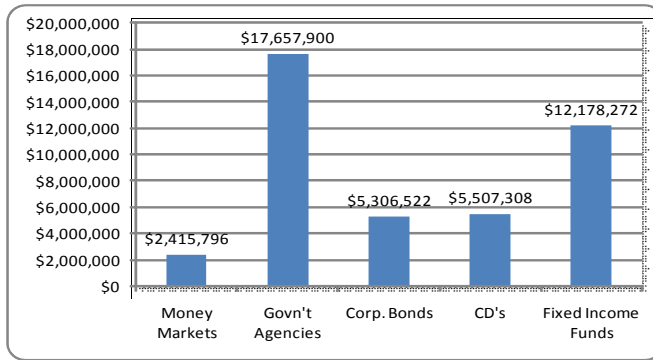
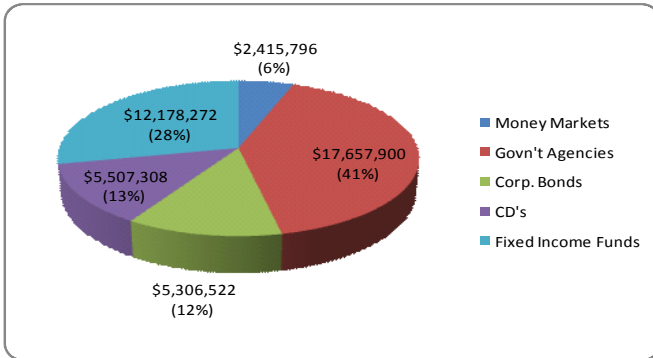
**Investment Allocation

For the Quarter Ending June 30, 2010**



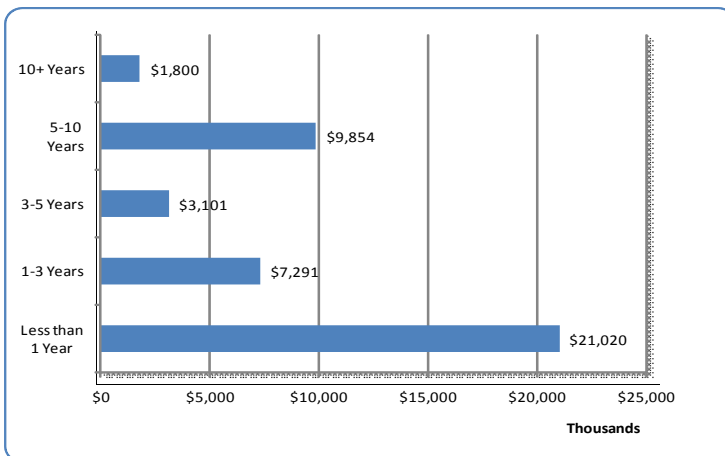
**Investment Duration

For the Quarter Ending June 30, 2010**



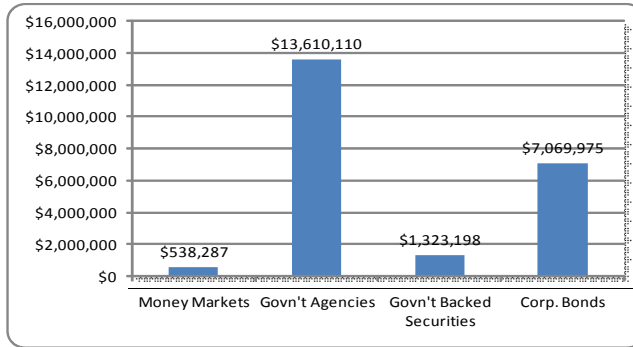
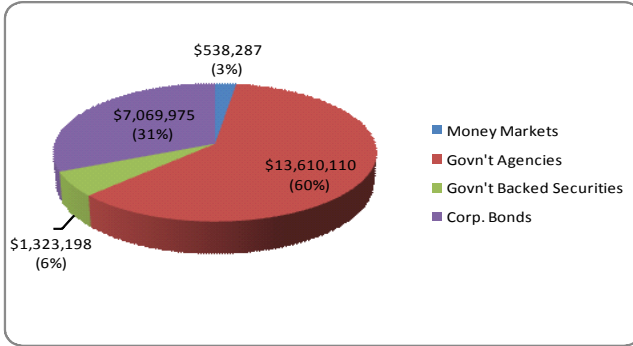

For the Quarter Ending June 30, 2010**



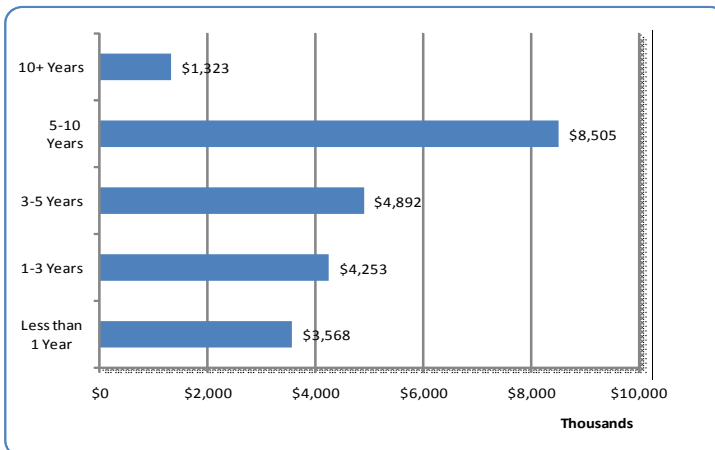

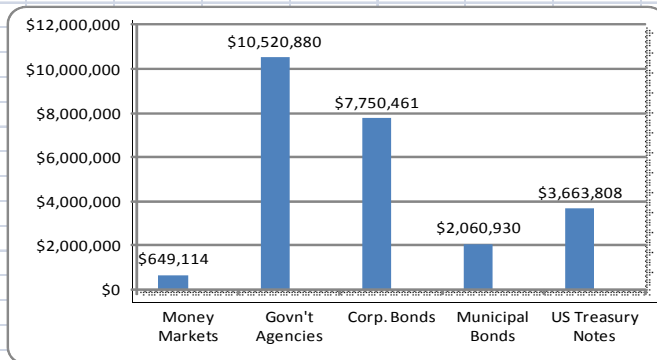
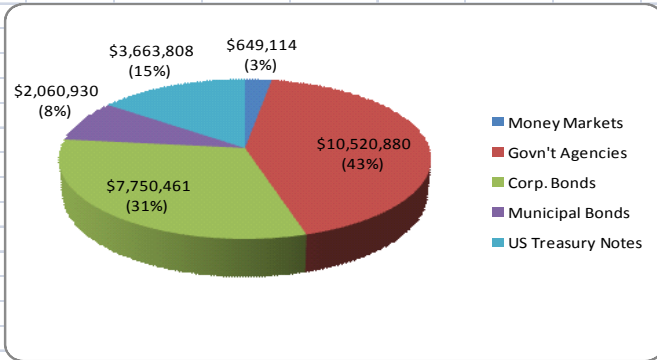

For the Quarter Ending June 30, 2010**



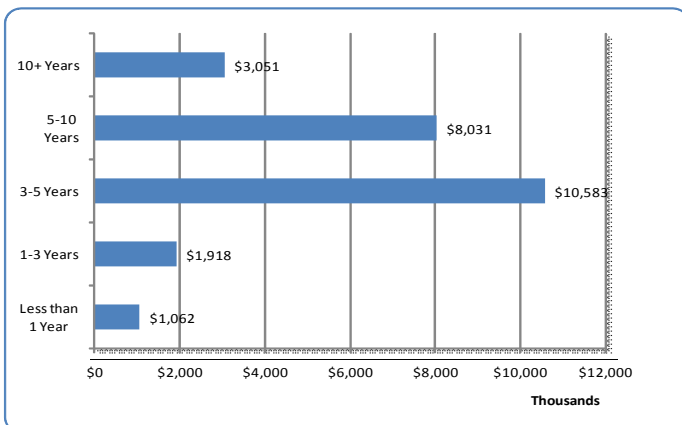

Revenues

State Appropriations

Due to budget cuts from the State of Indiana, the ARRA State Fiscal Stabilization funds used in the operational budget of the University was not received, leaving a \$2.2 million shortfall.

Student Fees

Through the fourth quarter ending June 30, Student Fees recorded are at 100.3% of budget. Gross student fees for the Fall and Summer II are below budget by \$231,283 and \$264,830. Student fees for Spring and Summer I are above budget by \$146,665 and \$492,051.

Other Fees and Charges

Other Fees and Charges are at 151.2% of budget. This is due to workshops, credit exams, college challenge, incarcerated program, deferment charges, and admission applications.

Sales and Services

Sales and Services finished the year at 97.2% of budget, as parking violations fell below the budgeted amount. Revenues were up over last year's level by \$331,992 due to IU Medical Center reimbursement of administrative expenses and the Student Health Center reimbursement.

Rent, Interest, Dividends, and Gifts

Rent and Interest are at 100.4% of budget and are comparable to the prior fiscal year.

Miscellaneous Income

Miscellaneous Income for the year was 100.9% of budget, as salary reimbursement was above the budgeted amount. Income was above the previous year by \$334,659 attributable to an increase from Residential Life and Student Recreation Center for utility costs of \$300,000.

Expenses

Salaries and Wages

Salary and wages reflect an increase of expense from the previous year of \$4,138,614. This increased cost includes \$4,505,774 of retirement incentive expense and \$371,754 of severance pay. Reversion from non-retirement salary and benefit budgets, income, and the carry-forward tax were used to offset these increases.

Fringe Benefits

Fringe benefits show expense above last year's totals by \$888,523. This reflects increased medical insurance costs for both active employees and retirees and additional costs associated with the retirement incentives for PERF and FICA contributions.

Student Wages

Student wages used 88.5% of the budget allocated for this expense. The remaining budget of \$435,436 is carried forward into fiscal 2011 to supplement the new year's budget. Expenses rose by \$195,852 from 2009 to 2010 reflecting the third step in a three-step increase in the minimum wage passed by Congress in 2007. The third step was effective July 24, 2009.

Utilities

For the year, utilities had a budget reversion of \$1,307,814. This was a result of savings in electricity and natural gas. These funds were used to cover other operating shortages, and the remaining balance was transferred to the Strategic Initiatives Reserve at year end.

Training, Representation and Travel

Training, Representation, and Travel used 76.0% of the budget. The \$328,687 positive reversion will be carried forward into the new fiscal year and will be used to supplement the 2010-11 base budget allocation.

Student Aid

Student Institutional Aid shows a \$285,007 favorable variance, which will carry forward into the 2010-11 year. This includes \$250,000 in graduate assistant scholarships to be used for Summer 2010 awards and \$34,259 of Terre Haute Med Ed scholarships. Student institutional awarded aid expense is less than the previous year to date by \$719,416. This decline in student aid expense is attributable to changes in the Illinois fee waiver program limiting the fee to 125% of the undergraduate or graduate resident fees and the change in the IU medical students' waiver.

Bond and Interest

The funding for the Central Chiller was transferred in June, leaving a reversion of \$31,695. These funds were used to cover other operating shortfalls.

Supplies and Expense/Transfers

Supplies and Expense show a year-to-date variance of \$4,367,597. This represents the cumulative carry forward budget unspent in 2010 and prior years, which will supplement 2011 expenditures.

Repairs and Maintenance

Repairs and maintenance show a \$236,424 positive budget reversion, which will carry forward into the new year.

Capital Equipment

Capital equipment shows a \$971,376 favorable year-to-date budget reversion that will carry forward into the 2011 fiscal year. Many departments utilize a multiple-year planning approach for the purchase of capital equipment utilizing carry forward dollars.

Strategic Initiatives Reserve

The amount shown reflects the net amount of various budget reversions and is set aside for one-time funding of strategic priorities of the University.
