 - a. Proposals
 - 1) ELED 250 – Proposal was brought off the table from September meeting. R. Donlan described this proposal to add background check requirement in the catalog so that incoming transfer students are aware of the requirement.
L. Sperry motioned to approve adding background check requirement to the catalog for ELED 250/250L. M. Lee seconded. Proposal was passed. Vote: 15-0-0
 - 2) Elementary Education Major – R. Donlan spoke to this proposal.
J. Brosmer motioned to approve substituting HIST 113 for HIST 213. L. Sperry seconded. Proposal was passed. Vote: 15-0-0.
 - 3) Science Education Major – Physical Science Concentration and Earth, Space, Science Concentration
E. Hampton motioned to approve the proposal stating students passing MATH 112 and MATH 115 with a C or better will have MATH 131 waived to allow for more elective science courses for Middle School Science Major. R. Donlan seconded. Discussion from D. Ballard and C.

Taylor that MATH 112 and MATH 115 is being phased out and replaced with MATH 116. E. Hampton motioned to amend MATH 116 as substituting for MATH 112 and MATH 115 in the original proposal and that students must earn a C or better in course. L. Sperry seconded. Proposal was passed. Vote: 14:0:0

5. Dean's Report – Janet Coleman
Requested that TEC meet two times/month for courses needing fast-tracked through the approval process at the college level. Dean Coleman suggested not making this change until Spring semester. L. Sperry will have K. Meeks set up two meetings per month and will cancel the second meeting if not needed.
6. Associate Dean's Report – Linda Sperry
Discussion about GPA requirement. L. Sperry advised that each major check catalog entries for 1) 3.0 admission requirement; 2) 2.7 provisional admission requirement; 3) CAEP language should replace NCATE language; and 4) no reference to CASA.
