  - a. Proposals
    - i. Student Appeal BCP1- Judy Sheese/ Elsun Seung. Student majoring in science education took test on Jan 6. Student passed but is awaiting writing scores. Student is petitioning to register for BCP1 today and will provide the writing score at a later date. Petition withdrawn due to acceptable test scores. Student will be advised to register today.
    - ii. EPSY 520, SPSY 500, SPSY 666, SPSY 666L, SPSY 670, SPSY 678, SPSY 680, SPSY 682, SPSY 684, and **SPSY 685. SPSY 708 needs to be added.** SPSY 708 is being added in order to focus on social justice and advocacy. (Chavez Phelps) These curricular revisions would help the program meet 21<sup>st</sup> century students, assist us in meeting NASP and APA accreditors, and would attract prospective students.

S. Husinga presented special education courses to add student teaching and practicum. Courses are presented in curriculog but program update is not. Proposal will be forthcoming. The courses will allow students to acquire license. Add-on licensure for intense intervention and 2 courses to prepare them for career change for mild licensure. There is an increasing need in Indiana, responds to growing need, and will respond to student interest.

5. Dean's Report – Janet Buckenmeyer

Thank you for the support during CAEP site visit. 6 areas of improvement have been provided preliminarily to give us a focus for next 7 years. One area to specifically focus on for TEC is diversity. Focusing on diversity of experience for each candidate is critical. CAEP also expect candidates to have a variety of grade level experiences. Placements must also be made with technology considerations in mind. Accreditation is a constant work in process.

J. Brossmer- update about technology. All teachers will have chrome books. There is a process to select an LMS. Device rollout is staggered throughout Vigo County.
